Then, John Walker made a motion which was seconded by David Simpson to set the contribution rate for the new plan year at 200%. Voting FOR-Commissioners May Jr, Gaines, Simpson and Walker. Voting AGAINST-Judge McDowell. Motion carried.

HIRING FREEZE CONSIDERATION

After discussion, no action was taken.

EARLY RETIREMENT INCENTIVE POLICY APPROVED
After discussion, Jackie Don May Jr made a motion which was seconded by David Simpson to adopt an Early Retirement Incentive Policy for Wheeler County with the provision that employees aged 60 to 64 years on September 30, 2024 that retire on September 30, 2024 shall be carried on the Wheeler County Health Insurance plan until their 65th birthday with no cost to the retired employee, and full-time vested employees over the age of 65 years old that retire on September 30, 2024 shall be paid an early retirement incentive of \$15,000.00, all effective September 30, 2024. Motion carried unanimously.

SHERIFF AND CONSTABLE SERVICE FEES FOR 2025 APPROVED

Jackie Don May Jr made a motion which was seconded by John Walker to set the Sheriff and Constable fees for service as the same rates as in 2024. Motion carried unanimously.

TAX COLLECTOR-APPROVAL OF CERTIFICATION OF 2024 TAX APPRAISAL ROLL-\$1,428,195,846.00

John Walker made a motion which was seconded by David Simpson to approve the Certification of the 2024 Appraisal Roll as submitted by Kimberly Morgan, Chief Appraiser. The certified taxable values total \$1,428,195,846.00. Motion carried unanimously.

TAX COLLECTOR-2024 TAX RATE CALCULATION WORKSHEET ACCEPTED

After discussion, John Walker made a motion which was seconded by Jackie Don May Jr to approve the 2024 Tax Rate calculation worksheet showing the no-new revenue rate and the voter-approval tax rate. The no-new revenue rate will be \$0.61698 and the voter approval tax rate will be \$0.63857. Motion carried unanimously.

TAX COLLECTOR-DISCONTINUE PARKS & WILDLIFE SERVICE SERVICES, effective August 1, 2024

the request of Cindy Brown, Tax Collector, Jackie Don May Jr made a motion which was seconded by Phillip Gaines to discontinue the collection of the Texas Parks & Wildlife service fee for boat tags, effective August 1, 2024. Motion carried unanimously.
